#### What is the future for your occupational health service?

As we have previously reported in these regular Practice newsletters, the Local Area Team at NHS England are continuing to fund provision of occupational health services until 1st April 2015. However, it is highly doubtful there will be comparable funding from April 2015. We understand there is a small possibility of minimal funding remaining, which most probably will be allocated to emergency needlestick cover for medical staff. The responsibility for commissioning occupational health services will fall to local Federations, Clinical Commission Groups and potentially even individual Practices. Occupational health service provision is a significant issue warranting immediate attention to ensure suitable provision and seamless transfer of services from 1st April 2015.

At Workplace Health & Wellbeing, we view this as an exciting opportunity for the current service provision to be remodelled to meet developing organisation need. Using the CQC requirements as a framework, we can offer varied service packages which ensure essential occupational health services are provided, whilst proactive occupational health services remain available under more flexible, bespoke arrangements.

To achieve a continuous service provision from April 2015, Workplace Health and Wellbeing would welcome the opportunity to meet key stakeholder within CCG's and Federations. ### FREE NHS Health Checks. Now available in your workplace.

We are now working in partnership with Public Health Norfolk to offer a national disease prevention programme called "NHS Health Checks" and are able to bring this to your workplace free of charge.

The Health Check is for aimed at those aged between 40-74 years and looks for early warnings for heart disease, stroke, diabetes and kidney disease. The good news is all these conditions are preventable!

The Health Check will take no longer than 30 minutes and will include;

- Blood pressure measurement
- Height and weight
- A lifestyle assessment, which will help employees to understand how diet and activity levels could affect health.
- A simple blood test to check cholesterol and/or blood sugar levels if required

### Are staff suitably protected?

We have provided immunisation guidance regularly in previous newsletters, but it's apparent the message still needs to be promoted especially in line with CQC assessment requirements. In 2007 the DOH published guidance on Health Clearance for tuberculosis, Hepatitis B, Hepatitis C and HIV. This document also detailed the other vaccinations required by all Health Care Workers which includes GPs, Dentists, Practice Nurses, Dental Nurses, Receptionist, Cleaners.

#### The key areas

- Hepatitis B Health care workers are encouraged to have Hepatitis B protection if they come into contact with blood and body fluids.
- Exposure Prone Procedure (EPP) Clearance - If your staff perform surgical procedures / dentistry, they need to have EPP clearance, which is a combination of hep B / C and HIV tests depending on when they commenced practicing EPP procedures.
- TB Protection. Immunity is tested by undertaking a Mantoux test / OH professional checking a BCG Scar. If you have employees coming to work for you from High risk TB countries then additional screening tests are necessary.
- Chickenpox If employees are unsure about their immunity it can be checked by a blood test. For those not immune there is vaccine available for health care staff.
- Measles, Mumps, Rubella (MMR) all staff should be able to demonstrate immunity or have the vaccine.

## Incident of sharps and blood/body fluid incidents are on the rise.

In 2013/4 there were in excess of 90 needlestick and sharps reported incidents, within Norfolk GP & Dental NHS Practices. This is an increase on previous years and the majority of the incidents were preventable with improved staff awareness.
